3. An **affidavit of Rs. 50/-** duly attested by the **Executive Magistrate** is to be submitted by the parents of selected wards. The affidavit should state:
  - The **Date of Birth** certificate that we have submitted is correct and no change has been made in the **Date of Birth** to seek admission to this school.
  - We will **not file any case** against the school to change the **Date of Birth** at any point of time after the child's admission in the school.

4. Bring two recent passport photographs and photocopy of aadhar card of child.
5. On the day of admission **both the parents along with their child** should be present. The measurement of the child for uniform will be taken on the same day.
