Please note: Negligence and failure of the parent of UKG to admit their ward to Class I on the above stipulated dates will result in losing the seat for the said class. Both the parents should be present to fill the Admission form of class I. Correct information must be given in the admission form. Bring original and Xerox copy of date of birth certificate of child duly attested by the Gazetted Officer or Executive Magistrate. The date of birth certificate should have the name of the child and the parents written on it. Date of birth, spellings of names and surnames must be correctly written. No change or correction will be entertained once the entries are done in the school records. Therefore, change of name or surname should be correctly thought of before making the entries in the Admission Form. The student's Aadhaar Card Xerox copy and two passport photographs are to be brought on the day of admission.

An affidavit of Rs 50 /- duly attested by the Executive Magistrate is to be submitted by parents. The affidavit should state:

- The Date of Birth certificate that we have submitted is correct and no change has been made in the Date of Birth to seek admission to this school.
- We will not file any case against the school to change the Date of Birth at any point of time after child's admission in the school. (Sample copy of the affidavit is given here below)
